Background

Go Green Environmental Ltd is a textile repurposing and disposal company. We are accredited with the Environment Agency as upper tier waste carriers. We hold all the relevant legal documentation when dealing with textile waste and are known to Carpet Recycling UK.

Based within the Liverpool City Region, the purpose of Go Green Environmental Ltd, is to provide both a local and national outlet for various companies within the textile sector when disposing of their textile waste. Repurposing sits higher on the waste hierarchy than recycling, in-turn produces less CO2, and it is for these reasons that many companies throughout the UK will choose to work with us.

Requirement

The Supplier for ISO consultancy services would be that of aiding Go Green Environmental Ltd to set up and obtain ISO's for the following accreditations, 14001/ 9001 and 18001. As Go Green Environmental aims to expand we aim to efficiently demonstrate the aforementioned ISO's to the relevant standards. Also, the procedures put in place must facilitate our expansion, so the supplier when aiding in the production of the standards must keep this in mind.

Deliverable Timescale

Commencing April 2021, completion by July 2021

Indicative Budget

Between £6,000 - £9,000

Evaluation Criteria

Quotations will be assessed and scored on the following criteria:

Quality/ Technical Merit (50%)

Supplier must demonstrate they have the technical and professional capability to deliver the requirement.

Delivery Timescale (20%)

Supplier must demonstrate they can deliver the requirement to timescales above.

Cost/Value for money (30%)

Does supplier offer value for money. This will not necessarily be the cheapest quote.

Scoring Methodology

4 Excellent	Proposal meets and, in some places,, exceeds the required standard
3 Good	Proposal meets required standard
2 Acceptable	Proposal meets the required standard in most respects, but is lacking or inconsistent in others
1 Poor	Proposal falls short of expected standard
0 Unacceptable	Completely or significantly fails to meet required standard or does not provide the relevant answer
