



## **REQUEST FOR QUOTATION – COMPRESSED AIR SYSTEM**

#### Background

Commercial Colours Ltd (CCL) are an established commercial vehicle body in the northwest and North Wales. We carry out crash repairs on all sizes and types of commercial vehicles plus painting of new and used commercial vehicles. Our client base consists of owner drivers and small operators right up to the major fleets that are seen on Britain's roads every day. Due to increased demand, we are looking to expand our operation into a larger site.

#### Requirement

We require a new compressed air system comprising of the following;

1 x New air compressor, 8.5 bar and 260cfm capacity, preferably variable speed.

- 1 x New air compressor, 8.5 bar and 100cfm capacity, preferably variable speed.
- 1 x Refrigeration dryer with capacity for the larger above machine.

1 x Inlet and outlet filters for the dryer.

Safe installation for the above equipment.

Pipe work for the two workshops of approximately 150m of pipe work with 30 drops and air connectors.

Pipe work supply to 3 commercial booths, 2 van booths and 1 x missing room. Approximately 100m.

#### **Deliverable Timescale**

We expect the project to commence no later than 1<sup>st</sup> March 2022, and to be completed by 31<sup>st</sup> May 2022.

#### **Evaluation Criteria**

Quotations will be assessed and scored on the following criteria:

#### Cost 10%

Does supplier offer value for money. This will not necessarily be the cheapest quote

#### **Deliverability Within Specified Timescales 20%**

Supplier must demonstrate they can deliver the requirement to timescales above

#### **Meeting Specification Details 40%**

Supplier must demonstrate all specifications met

#### Supplier Suitability 30%

Supplier must demonstrate they have the technical capability and experience to deliver the requirement

#### Scoring Methodology

4 Excellent	Proposal meets, and in some places exceeds the required standard
3 Good	Proposal meets required standard
2 Acceptable	Proposal meets the required standard in most respects, but is lacking or
	inconsistent in others
