



REQUEST FOR QUOTATION FOR BODYSHOP DUST EXTRACTION

Background

Commercial Colours Ltd (CCL) are an established commercial vehicle body in the northwest and North Wales. We carry out crash repairs on all sizes and types of commercial vehicles plus painting of new and used commercial vehicles. Our client base consists of owner drivers and small operators right up to the major fleets that are seen on Britain's roads every day. Due to increased demand, we are looking to expand our operation into a larger site.

Requirement

We have the requirement for a body shop dust extraction system comprising of the following;
8 x suspended dust modules at 2m level with suction flap, twin 240v socket, twin ¼" PCL air couplings.

8 x wall fixed connections with twin suction flaps.

1 x dust extraction plant to serve the 16 extraction points fitted with an automatic filter cleaning mechanism.

Deliverable Timescale

We expect the project to commence no later than 1st March 2022, and to be completed by 31st May 2022

Evaluation Criteria

Quotations will be assessed and scored on the following criteria:

Cost 10%

Does supplier offer value for money. This will not necessarily be the cheapest quote

Deliverability Within Specified Timescales 20%

Supplier must demonstrate they can deliver the requirement to timescales above

Meeting Specification Details 40%

Supplier must demonstrate all specifications met

Supplier Suitability 30%

Supplier must demonstrate they have the technical capability and experience to deliver the requirement

Scoring Methodology

4 Excellent	Proposal meets, and in some places exceeds the required standard
