New Markets 2 ERDF Growth Platform

Growth Platform's New Markets 2 (NM2) is a successful support programme which allows local businesses to access a grant towards the cost the cost of consultancy or agency fees, to help your business grow.

Where a business is looking for funding support towards a bespoke project and wants to choose their own supplier, eligible businesses can receive a 35% grant to the cost (excluding VAT).

New Markets 2 ERDF Growth Platform

New Markets 2 ERDF: Growth Platform— Project examples

- Marketing & PR Campaign for a new product
- ISO 13485
- Video production
- CRM development

Business eligibility includes:

- Based within Liverpool City Region
- Already trading (cannot be used for start up / set up costs)
- Cannot have committed to begin working with a supplier (as procurement must be evidenced)
- Cannot have already received New Markets 2 ERDF support

Project eligibility includes:

- cannot have begun the work
- will cost over £3,000
- will complete by 31st May 2023

An insight into Real-world Validation



What is Real-world Validation

Real-world validation (RWV) is a methodology that uses real-world data to determine, in a non-controlled environment, the effectiveness, and the outcomes to patients, staff and the health economy of health innovation.



Key benefits of RWV

- + Time and cost effective
- + Captures the 'so what' of an innovation
- + Collaborative approach
- + Addresses real-world needs
- + Robust real-world evidence
- + Cost-benefit analysis
- + Product development



RWV and the commercialisation process

RWV validates the innovation's value proposition against evidence-based protocols and the market competition.

At the same time, it evidences the effectiveness of the innovation, including its impact on patient health outcomes and the wider health ecosystem.

Real-world evidence helps businesses strategically position products within the health ecosystem. It improves the pitching of products or services to commissioners, positively influencing the scale-up process.



Investing in RWV

Investing in RWV is as important as investing in a business's development, marketing and sales. Validation, evaluation or research are crucial for any company to convince commissioners to buy into their innovation.

RWV helps businesses demonstrate that their innovation is more efficient than the competition, provides better health outcomes, and can be replicated in different contexts.
