Background Hybrid Technical Services are a private training provider offering apprenticeships and professional training and assessment in Gas, Plumbing and Electrical Installation. We are looking to make some significant investment in the premises, specifically a section of underutilised mezzanine space, in which we are looking to create a specialised training facility in Green and Renewable Energy technology solutions. Our current ground floor facility is at maximum capacity, so we are looking to expend into the existing first floor with the creation of three classrooms and two workshops. This renovation will give Hybrid customers the opportunity to undertake the highest level of professional training in a real working environment and will support the City Region to achieve their Net Zero carbon target in 2040.

Requirement Demolition of some existing interior structures, strengthening of existing floor, construction of three additional classrooms for increased delivery and two workshops to house renewable energy training equipment. Construction of staircase and all accompanying fixtures and fittings. Construction of false ceiling and floors then fitting of appropriate flooring throughout.
